OSL PERFORMS A WIDE RANGE OF MUSICAL PROGRAMS IN THE NEW YORK TRI-STATE AREA, MOST NOTABLY A THREE-CONCERT SERIES AT CARNEGIE HALL, A THREE-WEEK BACH FESTIVAL IN JUNE, A MULTI-CONCERT RESIDENCY AT CARAMOOR SUMMER FESTIVAL, THE WEEK-LONG DEGAETANO COMPOSITION INSTITUTE, A MULTI-PERFORMANCE SEASON WITH PAUL TAYLOR AMERICAN MODERN DANCE, AND A MULTI-CONCERT CHAMBER MUSIC SERIES AT MULTIPLE VENUES IN NEW YORK CITY. SINCE ITS OPENING IN 2011, OVER 600 ENSEMBLES, INCLUDING 59 ORCHESTRAS, 55 VOCAL AND OPERA GROUPS, AND 500 CHAMBER MUSIC GROUPS REPRESENTING OVER 40,000 MUSICIANS HAVE RENTED OVER 35,000 HOURS OF TIME IN THE CENTER'S SIX SPACES.
